LIMITED 3 YEAR WARRANTY TO ORIGINAL PURCHASER WITH PROOF OF PURCHASE

This Best Chest Murphy Bed and / or Guest Chest Murphy Bed , are supplied and distributed by Best Chest Murphy Beds Inc. and / or Guest Chest Murphy Beds Inc., delivered new, in the original carton to the original consumer purchaser, and are warranted by Best Chest Murphy Beds Inc. and / or Guest Chest Murphy Beds Inc. against manufacturing defects in materials or workmanship for the limited warranty period of:

Three (3) YEARS on the Sleep Chest Cabinet;

During the applicable warranty period, if the wooden frame or solid wood Platform fails structurally (i.e., broken frame) within three (3) years from the date of original purchase, we will, at our Sole option, choose to repair or replace the affected component in the original color and style or in a similar color and style if the original has been discontinued. All Repairs and or Product Replacements are warranted for the remaining portion of the original product's warranty. This limited warranty covers manufacturing defects in materials or workmanship encountered in normal household, **Non-Commercial** use of this product.

Limited Warranty Exclusions

This warranty does not cover the following

- Damage that occurs during shipping and / or delivery, installation, and or uses for which this product was not intended.
- Damage caused by unauthorized modification or alteration of this product.
- Damage from Operator Error or misuse.
- Natural Imperfections in the wood surfaces and or cosmetic imperfections including nicks, dings, chips, in finishes due to normal operation.
- Damage caused by moving, abuse, misuse, accident, fire, floods, or other acts of nature or God.

Authorized Retailer

Residential Use Only
